SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation

Move affected person to fresh air at once. Get medical attention immediately. Keep affected person warm and at rest. For breathing difficulties oxygen may be necessary.

Ingestion

Rinse mouth thoroughly with water. Get medical attention. Give plenty of water to drink.

Skin contact

Wash skin thoroughly with soap and water. Get medical attention if any discomfort continues.
